- Eligibility for vote or serve on the Board of Directors of ATA or ATA Japan.

## Dues Payment

- The initial dues will be calculated on a monthly pro-rata basis from the month of application through the following May.
- From the second year onward, annual dues will be charged in full and are payable by the end of May.
- Once the application is received, an invoice will be issued and sent via email.
